I understand that KASH is a forum that serves to promote health science through dialogue and exchange among scientists, health practitioners, development partners and policy makers and that its findings, conclusions and recommendations directly contribute to the national discourse on not just managing pandemics but also a reflection on our Universal Health Coverage (UHC) journey among other key developments. I challenge you, as the KEMRI fraternity to do more in other areas of research to address the many health challenges we face in Kenya. Let this year's theme: "Building a resilient health sector through investments in data science, research evidence, technology and innovations", be a new beginning for us in the health sector.

I look forward to robust discussions that result in solutions that are not just timely, but responsive and result-oriented to our current realities in our health systems.
