The Program has been conducting cutting-edge research and program evaluation in western Kenya to provide high quality data for evidence-based policies on malaria control. Location: Kisumu County

Job Summary

The Pharmaceutical Technologist will report to the Pharmacist in-charge and will be responsible for ensuring that the pharmacy assignments are executed in the highest standards possible as per the AGREE Trial study protocol, GCP and GPP guidelines. S/he must be flexible and work within the existing structure, in a professional and ethical manner with competence, accountability and integrity.

a) Job Specification:

- Dispensing prescribed medications and pharmaceutical preparations
- Verifying and maintaining information relating to patients
- Ordering and recording of drugs and other supplies;
- Verifying and maintaining records relating to patients;
- Custody and storing of drugs;
- Ensuring that the working environment meets the stipulated requirements
- Prepare pharmacy/drugs monthly reports

b) Person Specification:

- Diploma in Pharmaceutical Technology or its equivalent from a recognized institution;
- Registration Certificate issued by the Pharmacy and Poisons board;
- Good Clinical Practice (GCP) and Good Pharmacy Practice (GPP) - Added advantage
- Proficiency in computer application
